## Uvodnik

Prva četiri priloga novog broja časopisa Ekonomske teme predstavljaju dopunjene, proširene radove prezentovane na međunarodnom naučnom skupu, održanom na Ekonomskom fakultetu u Nišu, 13. oktobra 2016. godine, pod naslovom Prioritetni pravci razvoja nacionalne ekonomije. Osim ova četiri, u ovom broju časopisa mesto su našla još četiri interesantna priloga autora iz zemlje i inostranstva, značajna u smislu doprinosa teoriji, ali i praksi funkcionisanja organizacija.

Prvi rad, sa naslovom *Efekti stranih direktnih investicija na profitabilnost preduzeća izvoznika u Republici Srbiji*, analizira iskustvo Republike Srbije u privlačenju stranog kapitala u lokalne izvozne kompanije, sa posebnim osvrtom na efekte stranog kapitala na profitabilnost tih kompanija.

Autor rada *Prvi koraci ka implementaciji bankarske unije i uticaji na bankarski sektor Evrozone* analizira trenutno stanje bankarskog sektora Evrozone i pokušava da identifikuje kako je uvođenje bankarske unije uticalo na dešavanja u tom sektoru.

*Uloga depozitnih finansijskih institucija u razvoju realnog sektora Republike Srpske* je treći rad, u kome autori analiziraju depozitne finansijske institucije koje posluju na području Republike Srpske i kako bi se determinisala njihova uloga u razvoju realnog sektora.

Namera autora rada naslovljenog *Posledice integracionih procesa u Evropi: Sektor logističkih usluga* jeste da utvrde kako su se stare članice EU 15 i nove članice EU prilagodile novom poslovnom okruženju i ostalim promenama u mikro i makro okruženju na evropskom tržištu logističkih usluga.

Na osnovu klaster analize i multiple regresione analize, autori rada *Interventna uloga konkurentnosti na odnos između održivosti i performansi turizma: Istraživanje na primeru zemalja Evrope* zaključuju da konkurentnost turizma utiče na performanse turizma analiziranih zemalja u pogledu broja turista i prihoda od turizma.

Rezultati istraživanja prikazanog u radu *Efekti doznaka iz inostranstva na ruralno i regionalno siromaštvo u Republici Srbiji* pokazuju da doznake imaju veći uticaj na siromaštvo ruralnih domaćinstava posebno na dubinu i oštrinu siromaštva.

Cilj rada *Primena intregrisanog AHP-TOPSIS metoda u oceni efikasnosti zdravstvenih informacionih sistema* jeste analiza i ocena efikasnosti zdravstvenih informacionih sistema u pružanju usluga zdravstvene zaštite. Ocena zdravstvenih informacionih sistema bazira se na višekriterijumskoj analizi efikasnosti, pomoću AHP-TOPSIS metoda.

## Editorial

The first four papers of the new issue of the journal *Economic Themes* represent the supplemented, extended papers presented at the international scientific conference, held at the Faculty of Economics in Nis, 13th October 2016, entitled *The Priority Directions of National Economy Development*. Aside from those four, in this issue of the journal, there are four interesting papers, whose authors are from Serbia and abroad, significant in a sense of contribution to the theory, but also to the practice of organisations' functioning.

The first one, entitled *Effects of Foreign Direct Investments on Serbian Exporters' Profitability*, analyses Serbian experience in attracting foreign capital into local export companies with a special emphasis on their profitability.

The author of the paper *The First Steps toward the Banking Union's Implementation and Effects on the Eurozone Banking Sector* analyses the current state of the Eurozone banking sector and tries to identify how the introduction of the banking union has influenced the developments within that sector.

*The Role of Deposit Financial Institutions in the Development of Real Sector in the Republic of Srpska* is the third paper, in which authors analyse the deposit financial institutions which operate in the Republic of Srpska in order to determine their role in the development of the real sector.

The intention of the authors of the paper entitled *Consequences of Integration Processes in Europe: Sector of Logistics Services* have tried to determine how the old EU-15 Member States and the new EU Member States adapt to the new business environment and other changes in the micro and macro environment in the European market of logistics services.

Based on a cluster analysis and multiple regression analyses, authors of the paper *The Intervening Role of Competitiveness on the Relationship between Sustainability and Tourism Performance: A Research on European Countries* conclude that tourism competitiveness influence tourism performance of analysed countries in terms of tourist arrivals and tourism receipts.

The results of the research presented in the paper *Effects of Remittances on Rural and Regional Poverty in the Republic of Serbia* show that remittances have a larger impact to poverty of rural households, especially to the depth and severity of poverty.

The aim of the paper *Integrated AHP-TOPSIS Method for the Assessment of Health Management Information Systems Efficiency* is to analyse and estimate the efficiency of health information systems in the provision of health care services. The evaluation of health information systems is based on multi-criteria analysis, by using the AHP-TOPSIS method.

We thank the authors for their contributions and reviewers for cooperation.
